(Rom. 1:21-27; I Cor. 6:9-20). This includes the promotion or celebration of non-heterosexual lifestyles. Unity Christian believes that biblical marriage is limited to a covenant relationship between a man and a woman.			
Unity Christian High School employees will maintain a lifestyle based on biblical standards of conduct. Failure to do so may result in a reprimand or, in some cases, dismissal from employment. It is the goal of UCHS that each employee will have a lifestyle where " He [Christ] might have the supremacy." Col. 1:18
